Hidden Dangers

Septic tanks are a potential life threatening danger. It is the owners responsibility to make sure tanks and openings are secured to prevent accidental or unauthorized access.

Numerous health issues are associated with entering septic tanks or exposure to the raw sewage inside. There are physical hazards of falls, drowning, and asphyxiation. Not to mention the biological hazards of infections and disease.

Septic tank covers should only be opened by a trained person or a professional. DO NOT attempt any troubleshooting or servicing if you are not trained! You may damage the system or worse, injure yourself or others.

Entry of a tank is a confined space. It should only be attempted if there is no alternative, the persons are trained for confined space entry, and the required protective gear is used.

Septic Tank Safety



Responsibility

The installing master plumber is responsible for the original construction. This includes initial code compliant condition of the septic system. Approved plans and a state sanitary permit are required for any installation or modification to a septic system. Manufacturers are required to have their products approved according to industry guidelines and administrative code. The septic tank (and rest of the system) is inspected by a local (usually county) official for code compliance.

After the initial inspection, responsibility doesn't end there. When maintenance is performed, the pumper or servicer should verify all tank(s) and openings are locked or secured.

However, ultimate responsibility falls upon the owner to make sure their tank is locked and secured from unauthorized access.

Safeguards

SPS 384.25(7)(h) states "Covers located at or above ground for openings larger than 8 inches in diameter shall be provided with locking devices or other effective measures to prevent unauthorized access." SPS 384.25(8)(b) also requires a warning label to be attached to the cover.

Be proactive - prevention is the key!!!



Check for chains and locks!
